

**Resolution no. 301/2022/2023**  
**Senate of Adam Mickiewicz University in Poznań**  
**17 April 2023.**

**amending the Regulations of doctoral schools**

Pursuant to Article 205(5) of the Act of July 20, 2018 - Law on Higher Education (Journal of Laws of 2022, item 574, as amended), the Senate resolves as follows:

§1

In the Regulations of doctoral schools of Adam Mickiewicz University in Poznań dated 26 April 2021, constituting an appendix to the Resolution of AMU Senate No. 83/2020/2021:

- 1) In §2, section 1 is replaced by the following:  
"1. The School shall provide doctoral training preparing for the doctoral degree in scientific and artistic disciplines as defined in accordance with the regulation";
- 2) In §3, section 8 shall be replaced by the following:  
"8) Regulation - the Regulation of the Minister of Science and Higher Education of 11 October 2022 on fields of science and scientific and artistic disciplines.";
- 3) In §9, section 10 shall be replaced by the following:  
"10. The results of the examinations and credits referred to in paragraph 9 shall be communicated to doctoral students not later than 14 days from the date of the examination or credit, in writing or by entering the grade in the appropriate computer system.".
- 4) §10 shall be replaced by the following:  
"A doctoral student shall submit a report, approved by the supervisor, on the progress of the educational program and the progress of the work included in the individual research plan to the director within the deadline set by him/her. The deadline shall be announced no later than October 15 of each year.".
- 5) In §13:
  - (a) section 3 shall be replaced by the following:  
"3. The director may also suspend training in cases other than those specified in section 1, if circumstances have arisen that prevent or significantly hinder the implementation of the individual research plan. The period of suspension of training may not be longer than one year.".
  - (b) section 5 shall be replaced by the following:  
"5. The suspension of training referred to in section 3 shall be made after consultation with the supervisor.";
  - (c) after section 5, the following section 6 shall be added:

"6. The doctoral student shall notify the director of his or her intention to resume training after the expiration of the suspension period, no later than on the last day of the suspension.";

6) In §15:

(a) paragraph 1 shall be replaced by the following:

"1. A doctoral student shall be removed from the list of doctoral students in the event of:

- 1) negative result of the mid-term evaluation;
- 2) failure to submit the doctoral dissertation by the deadline specified in the individual research plan;
- 3) resignation from doctoral training;
- 4) failure to start training;
- 5) violation of the prohibition referred to in Article 200(7) or Article 209(10) of the Law;
- 6) punishment with the disciplinary penalty of expulsion from the doctoral school.";

(b) the following section 1a shall be added after section 1:

"1a. In the proceedings for removal of a doctoral student from the list of doctoral students, in the cases referred to in section 1 item 5, the doctoral student shall be summoned to submit, within no less than 30 days, a resignation from training at another doctoral school or from employment as an academic teacher or researcher."

(c) section 2 shall be replaced by the following:

"2. A doctoral student may be removed from the list of doctoral students in the event of:

- 1) unsatisfactory progress in the preparation of the doctoral dissertation;
- 2) conduct inconsistent with the regulations or lack of progress in the implementation of the educational program and individual research plan;
- 3) failure to submit a current medical certificate stating that there are no contraindications to training;
- 4) failure to resume training after the expiration of the period of suspension from school."

7) The Appendix to the Regulations of Doctoral Schools is deleted.

## §2

The resolution comes into effect on 1 October 2023.
