We are pleased to inform you of our application procedures for our exchange program starting in October 2025. Please refer to the attached documents and send us the required application materials by the following deadline. Application must be sent through the department in charge of outbound exchange students at home universities by e-mail.

 - *JLPT level N3 or its equivalent preferred. Students who don't have Japanese skills equivalent to JLPT level N5 cannot be accepted.
 - * The MA/PhD students who wish to be enrolled in Tthe Special Courses for International Students of Graduate School of Natural Science and Technology provided in English must submit documents to certify applicant's English language proficiency

 - * Please attach a JPEG or JPG photo data
 - (Use only valid passport-style photographs, taken within the last six months.) to the application form.
 - (2) Photocopy of Passport (Copy of a page or pages with your name and passport number legible)
 - (3) Pledge of Financial Support (Form provided)
 - (4) Financial supporter's bank statement (Deposit balance statement)
 - *The statement must indicate the deposit has more than JPY 1,500,000.
 - Copy of the financial supporter's identification card
 - (6) Financial supporter's Job Certificate
 - *All the documents should be written in English or Japanese. Please attach Japanese or English translation to the originals in case written in any other languages.
- How to Submit
 - The subject of the e-mail should be "[University Name] Application for 2025 Exchange Program".
 - · Documents indicated to be submitted in PDF format should be combined into a single data file.
 - No need to mail the paper-based original documents to us.

Other Remarks:

- (1) Please nominate students who are physically and mentally healthy, are able to cope with life in Japan for the duration of their studies, also have a clear purpose for studying at Shimane University.
- (2) The number of the students to be accepted for each semester is up to the number stipulated in the agreement.
- (3) Exchange students coming for one academic year are asked to provide proof of having at least 1,500,000 yen available (750,000 yen for one semester) to cover living expenses and travel costs. We require this documented proof for immigration procedures. There is no scholarship for exchange students. We ask that you instruct the students to work diligently at their studies and not at a part-time job. Exchange students are responsible for providing enough money to live without a part-time job.
- (4) We will make efforts to allocate rooms of the International House and the Student Dormitory to exchange students. However, there is some possibility that they have to live in an off-campus apartment.
- (5) It is not permitted for students to participate in programs (including classes, courses, travel and so on) organized by any other institutions than Shimane University during the term of classes at Shimane University.
- (6) If a student's Japanese language ability is severely lacking, there is a possibility of frequent troubles on and off campus. <u>Please nominate students after careful consideration of their Japanese language ability.</u>
